

In making this application, I understand that:

1. The administration has full responsibility for placing my child in the proper grade and classroom.
2. Since the fees do not cover the actual cost of educating my child, we recognize that our participation is needed in prayer, service, and gifts in order to properly share in his/her training.
3. The school reserves the right to dismiss any student who does not respect its spiritual standards or cooperate in the educational process.
4. All students are accepted on a conditional basis. If acceptable progress has not been shown by the end of the first grading period he/she shall be withdrawn from the Westwood Christian School. The teacher's judgment shall be relied upon for the acceptability of the student's progress.

Statement of Cooperation

1. We pledge our loyalty to the aims and ideals of the school and will bring any and all questions and criticisms directly to the administration so that they may be properly considered by those in authority.
2. We will read the Statement of Faith and the Philosophy of Education and are willing to have our child trained in accordance with them.
3. We will read the Handbook and will cooperate fully in seeing that the rules and regulations laid down there are met.
4. It is my understanding that it is the school's policy to make no refunds on registration fees.
5. I give Westwood Christian School permission for my child to take part in all school activities, including bus trips, sports activities, and school sponsored trips away from the school premises.
6. I believe that discipline is necessary for the welfare of each student as well as for the entire school. I give permission for my child's teacher and/or other agent of the school to make and enforce classroom regulations in a manner consistent with Christian principles and discipline as set forth in the Scriptures.
7. I agree to hold the school and its agents harmless for any liability to my child or any guardian or parent thereof because of any claims on behalf of my child against the school or any agent thereof because of any injury or alleged injury to my child. Should legal action, for any reason, be taken against Westwood Christian School or any employee or agent thereof, on my child's behalf and the school or its agent not be found at fault, I agree to pay any attorney fees, court fees, damages or other costs that Westwood Christian School or its agent should incur to defend itself against such action, and would immediately withdraw my child from school as soon as such action has begun.
8. This Statement of Cooperation will be in effect for as long as my children listed (or others to be enrolled) attend Westwood Christian School whether it be in the preschool, elementary, middle-senior high or summer school.
9. I understand that should my marital status change that it is my responsibility to have a corrected Statement of Cooperation signed and updated and delivered to Westwood Christian School.
